- Eligible furnaces and boilers are smaller than 225,000 BTUH. Larger equipment is eligible for custom commercial rebates (see website).
- Equipment must be new. For conversion rebates, please call GMG or visit our website.
- Equipment must be installed by a contractor with all necessary licenses.
- Equipment must be installed in a home or business in Minnesota served by Greater Minnesota Gas, Inc.
- Renters must have landlord/owner approval.
- Paid invoice including the brand, complete model number and serial number must be included with this application.
- Only one rebate per item installed.
- It is the responsibility of the installation contractor and the customer to ensure that the installed equipment qualifies for the rebate. GMG confirms efficiency rating at www.ahridirectory.org. If the equipment does not meet the requirements, no rebate will be issued.
- Rebate funds are limited and will be paid on a first-come, first-served basis.
- Equipment installed under free warranty replacement does not qualify for the rebate.
- Greater Minnesota Gas, Inc. is not responsible if the dealer does not provide accurate information about the amount of rebate or equipment eligibility.
