The State of Minnesota established the Cold Weather Rule (CWR) to protect residential, heat-affected customers from disconnection when they experience difficulty paying their bills during the winter months. Minnesota's CWR runs

Minnesota Cold Weather Rule

Cold Weather Rule (CWR) Runs from **October 15th to April 15th** of each year. CWR protection is for **residential** customers only. Your CWR payment plan will depend on your household income.

How to Prevent Disconnection of Your Natural Gas Service

You **must** contact GMG to discuss your account and make a mutually agreed upon CWR payment plan.

What if I am currently disconnected when CWR starts?

To get reconnected, contact Greater Minnesota Gas, Inc. (GMG) to make a mutually agreed upon CWR payment plan.

CWR Payment Plans

You can request a CWR payment plan. All CWR payment plans expire April 15th.

Households with income **below** 50% of the state median may qualify for a payment plan equal to or less than 10% of their monthly income. GMG will offer to work with households with income **above** 50% of the state median with a mutually agreed upon CWR payment plan. If you receive energy assistance you may also qualify for GMG's Gas Affordability Program (GAP).

If a CWR payment plan cannot be mutually agreed upon, you have the right to appeal within 10 working days. Appeals can be directed to the Minnesota Public Utilities Commission (MPUC) by calling 1-800-657-3782, 651-296-0406, by visiting their website at mn.gov/puc or by emailing consumer.puc@state.mn.us.

Important! You must make and keep your CWR payment plan to receive CWR protection.

If you cannot make your scheduled CWR payment, you must contact us immediately to discuss an alternate payment plan. If you do not make your payments, your natural gas service may be shut off. If your service is shut off, GMG is not required to offer additional arrangements.

Third Party Notification

If you have trouble with your natural gas bills and notices, you may wish to delegate a third party to receive a copy on your behalf. This can be a friend, relative, church or community action agency. Please contact GMG if you are interested in delegating a third party.

Energy Conservation Tips:

- Install a programmable thermostat.
- Lower thermostat during the night hours.
- · Lower the temp of your water heater.
- · Block drafts around doors & windows.
- · Cover your windows with plastic during heating season.
- · Replace your furnace filters.
- Add caulk and weather strips to doors and windows.
- · Open your shades during sunlight hours.
- Remove window air conditioners during the winter months.
- Get your furnace and home checked once a year by a licensed professional.
